IMPORTANT INFORMATION FOR CAT OWNERS

1. Definition of a PENSIONER for concessional licensing purposes is as follows:
 - a. A person issued with a Pensioner *Concession Card i.e.:
 - i. Aged Pension
 - ii. Invalid Pension
 - iii. Widowed Pension
 - iv. Supporting Parents Pension
 - v. Carer's Pension
2. Maximum number of Cats to be kept on any premises is three (3) over the age of six (6) months. Dispensation can be given to keep more than the maximum number cats in some cases, but subject only to an Application for Exemption being submitted to Council for consideration and certain other conditions being met.
3. In addition to the cat registration number tag, it is also recommended that each cat has a tag on which is inscribed the owner's contact details. These are obtainable from the R.S.P.C.A., Pet Shops and other sources.
4. Cat owners are also reminded that cats six aged months and over must be registered at all times and sterilised and microchipped. Council also requests that cat owners inform Council immediately of any change in ownership, the death of a cat, change in address and/or contact details.
5. Failure to sterilise, microchip and register a cat may result in a \$200.00 penalty for each offence under the Cat Act.

COLLECTION NOTICE — Privacy and Responsible Information Sharing Act 2024 (WA)

The Shire of Bridgetown-Greenbushes collects the personal information requested in this form to assess and process cat registration applications, maintain animal registration records, administer and enforce the Cat Act 2011 and related legislation, issue registration tags, contact owners or nominated delegates, manage payments and concessions, and provide ranger and community safety services. The information collected may include owner and delegate names, dates of birth, addresses, contact details, concession information, offence or banning details, cat details, microchip information, supporting evidence, payment information and signatures. Some information is required by law or is otherwise necessary for the Shire to process this application. If required information is not provided, the Shire may be unable to process the application, issue or renew a registration, apply a concession, or provide the requested service.

The Shire may use or disclose this information where authorised or required by law, including to other local governments, WA Government agencies, law enforcement bodies, veterinarians, microchip registry operators, contracted service providers and debt recovery or payment processing providers, where relevant to cat registration, animal management, compliance, public safety, records management or payment processing.

The Shire will handle personal information in accordance with the Privacy and Responsible Information Sharing Act 2024 (WA), the State Records Act 2000 (WA) and applicable Shire policies.
